Definition:

Demurrage/Detention: The charge the merchant pays for detaining carriers container beyond the prescribed free time period. Unless otherwise stated, demurrage/detention charges are calculated per day, effective from the day following any free time expiry date (Including SAT, SUN or public holiday),

Demurrage Free Time: (Import) A period of time which is allowed to keep cargo and/or line equipment free of charge. Unless otherwise stated, demurrage free time is counted as from date of actual discharge to the date of equipment redelivered to Yang Ming designated depot.

Detention Free Time: (Export) Calculated as from day of empty container pick-up, until date of loading. Unless otherwise stated, detention charges are calculated per day, effective from the day following any free time expiry date(Including SAT, SUN or public holiday)

Date of Availability: (Import) Date (Calendar day) on which cargo is discharged and in direct term available for collection by merchant at container yard.

Free Time DG/IMO: No demurrage free time for dangerous or obnoxious cargo.

Working Day (W): All calendar days excluding Saturday, Sunday or public holiday

Calendar Day (C): All calendar days including Saturday, Sunday and public holiday

SOC: Equipment demurrage as per DC tariff until delivery taken, except IMO that apply DG tariff.

Reefer Surcharge: (Import) Equipment Reefer surcharge at port including plug-in, monitoring and electricity.

Doc. Process Fee Administrative Fee 195 SEK for the processing of an additional invoice.

PORT STORAGE & FEE

Definition:

Service charge from respective port for holding and storing the unit within secure and fenced terminal area until container picked-up or shipped. Rates are counting for normal Dry-van and High-Cube Containers. Obnoxious cargo, reefer-units, out of gauge pieces etc may be subject additional charges.



Port of Helsingborg

Storage of Loaded IMPORT units entitled to 7 calendar days free storage including the day of arrival. There after:

- 20´ - 219 SEK (Per started day)
- 40´ - 438 SEK (Per started day)

Storage of Loaded EXPORT units entitled to 7 calendar days free storage including the day of departure. There after:

- 20´ - 72 SEK (Per started day)
- 40´ - 144 SEK (Per started day)

Containers that need electrical connection will be charged a connection fee of SEK 285 followed by a daily electrical fee and temp-check of SEK 342 / day.

Units containing dangerous goods according to IMDG / ADR / RID code will be stored on a secluded area at an additional handling fee of SEK 320.

Copenhagen Malmö Port, CMP

Storage of Loaded IMPORT/EXPORT units entitled to 10 free calendar days including the day of arrival. There after:

20'	-	50 SEK (Day >10)
40'	-	100 SEK (Day >10)

Mälarhamnar - Västerås

Storage of Loaded IMPORT/EXPORT units entitled to 5 free working days including the day of arrival. There after units charged per day as per below matrix.

Containers that need electrical connection will be charged with a connection fee of SEK 276, followed by a daily electrical fee and temp-check from day 2 and onwards with SEK 343 / Unit and day.

Units containing dangerous goods according to IMDG / ADR / RID code will be stored on a secluded area at an additional fee of SEK 138

Port of Södertälje

Storage of Loaded IMPORT units is entitled to the day of arrival plus 3 additional free days. There after charged per day with:

20'	-	100 SEK (Day 5 - 6)
20'	-	200 SEK (Day >7)
40'	-	200 SEK (Day 5 - 6)
40'	-	400 SEK (Day >7)

Storage of Loaded EXPORT units entitled to the day of arrival plus 6 additional free days. There after:

40'	-	400 SEK (Per started day)

Containers that need electrical connection will be charged a connection fee of SEK 432 followed by a daily electrical fee and temp-check of SEK 275 / day. Containers that need to be reported in acc with NFA directives charged SEK 336/unit. Transport to Designated Point of Entry, DPE area, SEK 374/unit

Port of Norrköping

Storage of Loaded IMPORT units arrived with **VESSEL** is free of charge for 4 working days. (Arrival day + 3). There after:

Storage of Loaded EXPORT units departing by **RAIL** is free of charge for 2 working days (Arrival day +1). There after:

Containers that need electrical connection will be charged a connection fee of SEK 411 followed by a daily electrical fee of SEK 153 / day.
Daily control is charge by SEK 204/ Unit on weekdays and SEK 663 / Unit on weekends and holiday.

Units containing dangerous goods according to IMDG / ADR / RID code will be stored on a secluded area at an additional fee of SEK 290 / Unit

Gävle Container Terminal, GCT

Storage of Loaded units entitled to 5(Import) / 7(export) free calendar days including the day of arrival and departure. There after:

20'	-	97 SEK (Per started day)
40'	-	194 SEK (Per started day)

Containers that need electrical connection will be charged a connection fee of SEK 428 followed by a daily electrical fee and temp-check of SEK 214 / day.

Port of Stockholm, CTN Norvik

Storage of loaded units arriving/departing from the port is entitled to 5 free calendar days. There after:

20´	-	70 SEK (Day 6-7)
20´	-	264 SEK (Day > 8)
40´	-	0 SEK (Day 1-5)

Units with IMO-classed cargo are not entitled to any fee storage and is charged from day 1-8 by SEK 70 TEU/Day and >9 Day with SEK 308 TEU/Day

APM Terminals Gothenburg

Storage of Loaded IMPORT units entitled to 3 free storage working days. The free period includes the day of vessel discharge and the following three(3) working days.

Storage surcharges on units containing **dangerous goods** and/or **OOG** units benefit from free storage on the day of vessel discharge or day of vessel loading, and will not be debited for the first SAT and SUN.

Temperature controlled reefer units are exempted from free storage and debited from date of arrival until date of departure.

The surcharge for electric supply/temperature controlled units include handling, monitoring and power supply.
